#### **EDITORIAL**

#### Developing a new Strategic Plan for 2008-2011 - Involvement of National Committees

In order to respond effectively to the emerging issues in roads and transport, the World Road Association introduced its first Strategic Plan at the 1995 Montreal World Road Congress, and a revised Plan at each subsequent Congress. Each of these Plans was intended as a guide for the work of the Association, particularly the Technical Committees, for the following four year cycle. For each Strategic Plan, an extensive process of consultation with First Delegates of member countries, Technical Committee members and the members of the Association via its National Committees took place in order to identify priority issues, visions and directions.

For the 2008-2011 cycle, preparations started in 2005 with the dissemination of a survey to all First Delegates. After reviewing the feedback, a workshop with the Technical Committees chairs and secretaries was held in Berlin in June 2006 and the Plan was further discussed in the meetings of the Executive Committee and the Council. Most National Committees have been involved by the First Delegates in this process by participating in the respective countries responses. In addition, the Representative of National Committees collected those answers elaborated by National Committees, added the results of the Annual Conferences of National Committees in Beijing and Madrid, the regional meetings in Santiago de Chile, Vienna and the Benin and formulated a statement on behalf of the National Committees.

National Committees extend and complement the work of the First Delegates by comprising the scientific and private sector as well. Indeed many of the recommendations of National Committees representatives expressed a strong wish to keep the technical content within the themes of Technical Committees. If the Association would focus on policy issues only, the Association's reputation could be damaged while also losing influence and interest by those who have come to expect technical information about the state of the art and best practice worldwide, from the Association.

For the 2008-2011cycle, the Association's Road and Road Transport Goals will be delivered through seventeen Technical Committees, grouped in four Strategic Themes that focus on, respectively, sustainability of the road transport system, improving provision of services, safety of the road system and quality of road infrastructure. The first meetings of the Technical Committees in the new cycle are scheduled for March and April 2008. National Committees are supporting their First Delegates in the nomination procedure. Read more about the meetings and the Terms of Reference of each Committee on World Road Association's website.

The main lines (identification of the Strategic Themes, structure of the Technical Committees, main issues to consider) were approved by the 2007 Council in Paris. The comments expressed by Council members and later the outcome of the sessions of the 23rd World Road Congress in Paris, contributed further to the development of the current draft. The final version will result from the decision made by Council at its meeting in October 2008.




#### **Agreement between Austroads International Committee and REAAA Australian Chapter**

The REAAA Australian Chapter has indicated its willingness to enter into an agreement with the Austroads International Committee. The agreement will seek to link World Road Association activities in Australia to a broader audience; strengthen the links between the two organisations in the Asia/Pacific and provide enhanced benefits for the members of the REAAA Australian Chapter through greater access to World Road Association information and its activities. It is anticipated that the agreement will:

- recognise that activities of the REAAA Australian Chapter and Austroads International Committee are complementary and mutually beneficial
- increase knowledge and awareness of the World Road Association, its activities and benefits, amongst road professionals in Australia and the Asia Pacific
- increase benefits to members of REAAA through the provision of information and knowledge transfer activities of the World Road Association.

The agreement is expected to be endorsed at the next Austroads Council meeting in March 2008.

### PORTUGAL

Following a government decision, a new model for the management and financing of the road infrastructures sector was defined in 2007 and is being implemented.

This new model consists of:

- The creation of new body, Institute for Road Infrastructures, I.P., (InIR) an institute with public functions of regulation and supervision of the sector of the road infrastructures.
- The transformation of Estradas de Portugal, EPE (EP, EPE) into a state-owned limited company, with corporate autonomy, now designated by Estradas de Portugal, SA (EP, SA).

InIR is from now on, the Portuguese National Road Authority. InIR purposes are: ensuring greater transparency and cautioning in the relationship of the State with the EP, SA and greater transparency in the formation of prices and tariffs, always having in mind the public interest and the need of the strengthening of an emerging market.

InIR has as its main mission: to oversee the management and operation of the road network, to check the application of laws and regulations, the concession and sub-concession contracts, always having in mind the need for ensuring the implementation of the National Road Plan, as well as for ensuring the efficiency, equity, quality and safety of the road infrastructures, respecting the user's rights.

EP, SA, is now a concessionary company, which focuses on the conception, design, construction, financing, maintenance, operation, upgrading and enlargement of the national road network, under a long term concession contract between EP, SA and the state.

Vehicle combinations based on the modular concept Background and analysis






At the end of last year Nordic Road Association's TC 54 Vehicles and Transports completed the report Vehicle combinations based on the modular concept, Background and analysis (64 p., ISSN 0347-2485). The report is written by John Aurell and Thomas Wadman from Volvo Trucks.

The report is in English and it describes the development of weights and dimensions of heavy vehicles in Europe. It illustrates the background to the modular concept (EMS) and explains the advantages with the modular concept. The report provides an extensive analysis of the performance of a large number of conventional and modular vehicle combination types. # 13TH PIARC WINTER ROAD CONGRESS 8 - 11 February 2010 in Quebec City


