EDITORIAL

A new approach for National Committees (a new Memorandum of Understanding)

The 2010 Annual Meeting of PIARC National Committees was held on the occasion of the Council meeting in Budapest, Hungary on 20th October 2010. After a welcome speech by the President of the Association, Mrs. Leclerc, the representative of National Committees reported on the various activities of National Committees during the past year, followed by a discussion on the participation and representation of National Committees in the 2011 Mexico World Road Congress, the role of National Committees in the new marketing strategy of the Association and a new National Committees award, to be presented for the first time at the Mexico World Road Congress.

The benefit deriving from the work of National Committees within the World Road Association is evident. The lessons learnt from many discussions with countries having no National Committee, but in which there is an active road association at the national level, is the difficulty in establishing a specific new organization to serve as the National Committee. This is seen as a potentially competing organization and implies new resources for operating. By contrast, the idea of recognizing an existing organization which also acts as a national committee is a strategy which is much better understood and brings benefits to both parties, such as:

- for the national organization, it brings the prospect of an international opening and recognition,
- for PIARC, it brings the opportunity to rely immediately on a stable and active existing organization and a solid membership base.

The respective initiatives of the past laid emphasis on the creation of a specific new National Committee and do not contain any standard proposal to make official the recognition of an existing organization acting as a National Committee. On this matter, it seems that the right procedure is not to ask for an amendment of the statutes of the existing organization, but rather to solve this question through the signature of a protocol of agreement.

Future priority in the Association will be given to adopt and implement this new strategy. To avoid signing a different type of agreement for each new situation in a given country, a standard framework for the memorandum of understanding (MoU) has been developed and its implementation was agreed by the Communication and International Relations Commission, the Executive Committee, the Group of National Committees and the Council at the Budapest meetings.

Three items are to be noted: the aim is to sign the MoU with the agreement of the first delegate(s) of the country in question. The MoU shall be considered as finalized after it is signed by the first delegate. A clause has been introduced enabling both parties to terminate the MoU (to date, there was no clause in case of default by either party). The management of membership fees remains optional. When the existing organization is in a position to manage membership fees, an amendment will stipulate the rules for the sharing of fees and the transfer of funds to the General Secretariat, in accordance with the Blue Guide.

The standard process should be the following:

Process

- 1. The General Secretariat will lead the preliminary discussions based on the standard MoU framework.
- 2. The representative of National Committees on the PIARC Executive Committee and the General Secretariat will review the statutes and the internal rules of the organisation applying to act as a National Committee to make sure that their intents are in accordance with the spirit and values of PIARC, and that it is compatible with the activities of a National Committee.
- **3.**The executive committee (or equivalent) of the organisation applying to act as a National Committee shall approve the draft MoU.
- **4.** The representative of National Committees on the PIARC Executive Committee shall report to the Executive Committee and suggest that they endorse the draft MoU
- **5.**The MoU shall be signed by:

the chairman of the national or regional organization, the first delegate of the country concerned, the PIARC Secretary General, on behalf of PIARC.

This new approach will be offered to all countries which intend to establish a National Committee in the future. In my function as representative of the National Committees on the Executive Committee

I appreciate very much this new concept for the creation of National Committees and invite you to contact me or the Secretariat General if you are interested in establishing one to strengthen the co-operation between your national audience and the international network of experts provided by the World Road Association.

GERMANY

ERA-NET ROAD Conference on Climate Change

8 - 9th December 2010, Cologne (Germany)



Four research projects of the ERA-NET ROAD Program, known as RIMAROCC, IRWIN, SWAMP and P2R2C2, focused on issues such as risk assessment, winter maintenance, flooding and impacts on road pavements. The Project Executive Board's objective was to investigate issues of climate change adaptation that would provide tools for road authorities to identify and prevent future problems to road infrastructure. At the conclusion of this program, a final conference is being organized to present the findings and recommendations.

The event will expose practical outputs that can be applied across Europe, and will be important in facilitating the understanding of this research across the funding member states. FEHRL is organizing the event in collaboration with the German Federal Highway Research Institute, BASt.

The two-day conference will be hosted at BASt in Bergisch Gladbach (near Cologne), Germany. Bus transfers will be provided between the NH Hotel in Cologne and the conference venue at BASt. On the evening of December 8th, a get-together dinner will be organised at the Chocolate Museum near the medieval Christmas market.

New Contacts in Terms of Terminology and complementary Activities

XII Conference on Road Maintenance

Achieving efficiency in Road Maintenance

This Conference, held on 10 and 11 November 2010 has been a great success, gathering together 700 experts from both the Public and private sector.

In recent years, the Spanish State and all the road Authorities, without exception, have made an extraordinary effort to invest in the creation and improvement of road infrastructure, which it can be translated into an excellent road heritage, with a value of more than 80,000 million Euros, and consisting of more than 12,000 kilometers of high-capacity roads, 800 tunnels whose length exceeds the 400 meters, more than 6,000 bridges ... etc. In short, almost everything demanded by the Society and by the development needs during the last decades.

It is a fact that the integral maintenance enterprises, driven by the Administration, have successfully incorporated many of the actual technological developments to the road maintenance technique, as to improve the inventory, mapmaking, operations scheduling, dynamic evaluation of road items ...etc.

2010 ACTIVITIES REPORTED BY THE SLOVAK NATIONAL COMMITTEE

Seminars and conferences jointly organized by, or in collaboration with, national committee or technical committee members

The **Road conference 2010**, sponsored by the Minister of Transport, organized by the Slovak Road Society, focusing on road management and technical policy and legislation issues, road network development and modernization, funding and financing of road building, maintenance and operation, implementation of PPP projects (DBFO), experience in the introduction of electronic toll collection system as of 1st January 2010, the new Road act and the National System of Traffic Information being developed and to be co-financed by EU fund was held from 25th to 26th March 2010 in Bratislava.

12th **International Scientific Conference Q 2010** Preparing, Building and Financing of Road Network, sponsored by the Ministers of Education and Transport, organized by University of Žilina, Slovak Road Society branch at University of Žilina, focusing on road developing, building and financing, road pricing, toll collection system, road management systems, abuilding and maintenance technologies, system of quality, education, research and development took place 29th - 30th April 2010 in Žilina.

International seminar and Traffic Engineering Days, organised jointly by Czech Road Society and Slovak Road Society, focusing on implementing of important traffic projects, road repair and maintenance in urban agglomerations. 2nd – 3rd June 2010, Mikulov, Czech Republic.

14th Danube-European Conference on Geotechnical Engineering, organized by Slovak University of Technology, Faculty of Civil Engineering, Bratislava in cooperation with Czech and Slovak National Committee and world professionals, focusing on the latest experience in the field of research and practice, leading up to new methods of geotechnical design, followed by a meeting of the ISSMGE National Groups from the Danube river region, was held in June 2010 in Bratislava.

Conference on Road Traffic Safety, sponsored by the Minister of Transport, organized by Slovak Road Administration and focusing on road infrastructure safety took place in September 2010 in Vyhne.

XV Road Workers Days, organized 7th – 8th October 2010 in Nitra by the Slovak Road Society with a conference on actual road network development and Road Stampede contest of truck drivers' skills with participants from Czech and Slovak Republic sponsored by the Minister of Transport, and as guests, colleagues of the Czech Road Society.

7th International conference Transport Infrastructure in Cities, organized by University of Žilina, Slovak Road Society, Slovak Chambers of Civil Engineers, Transport Research Centre (Czech Republic) in cooperation with international professionals, focusing on sustainable development of transportation in cities and conurbations, was held 20th – 21st October 2010 in Žilina.

An **International Seminar of Road Management and PPP Projects** was jointly organized by the Department of Transportation Engineering of the Slovak University of Technology, Bratislava, the Slovak Road Society and the Slovak Chamber of Civil Engineers 18th – 19th November 2010 in Bratislava, focusing on quality of road infrastructure with the topics: Pavement management system, Pavement condition, Materials, Rehabilitation of pavements, Pavements and materials in PPP projects.

Meetings

A joint meeting of the Slovak and Czech Road Societies was held in September 2010. The agenda included the cooperation and coordination of activities for the XXIVth World Road Congress in Mexico 2011, particularly discussing papers being prepared, e.g. national reports, individual papers, prospects of related joint seminars and conferences as well as national delegations preparation to the congress coordination.

PIARC Slovak National Committee had to cope with the state administration reshuffle after these year's parliamentary elections. New first delegate Mr. Marian Hanták was appointed, replacing Mr. Pavol Kirchmayer, and some new national committee members of affiliated institutions replaced the former ones. Resuming of the work of national committee, backing of the technical committees members' activity and preparations for XXIVth World Road Congress attendance were the issues discussed at the joint meeting with the first delegate in early October.

SLOVENIA

New challenges for the Slovenian PIARC National Committee – Latest information on road-related activities in Slovenia

This autumn, from 20th-22nd October 2010 one event of major importance for Slovenian road community has been organized, **The 10th Slovenian Road and Traffic Congress**. The highlight of the event was the visit and opening speech of Slovenian president Dr. Danilo Türk and Slovenian minister for transport, Dr. Patrick Vlačič. Members of NC PIARC Slovenia have all been present at this congress, where in two days of discussions one could hear the latest news regarding future prospects, investments and activities in Slovenian road sector.

Slovenian transport experts agree that the road sector in Slovenia in the near future will be experiencing significant operational and financial difficulties. As Slovenian minister for transport, Dr. Vlačič pointed out, the all-national project of building the highway cross in Slovenia is successfully finished and it is time to move on to other modes of transport, namely to railway infrastructure. Hence, a big share of state budget will be reserved for the investments into Slovenian railways.

Members of the Slovenian PIARC community were among the first to recognize this threat to the road industry in Slovenia before it was publicly announced and the recently elected new Governing board of NC PIARC Slovenia, headed by the new president Mr. Vili Žavrlan, had already taken some actions. It was planned to organize the high level workshop 'Maintenance and road development in Slovenia in relation to the financial crises' already during the above mentioned 10th Slovenian Road Congress and some eminent guests from the PIARC community were invited to participate. Unfortunately, the date of the 10th Slovenian Road Congress coincided with the date of the PIARC Council meeting in Budapest, so the workshop had to be postponed until the spring of 2011.
